HEAD OFFICE: VILLAGE RAMNAGAR, P.O. HAROTHA, TEH. EGLAAS, JANPATH ALIGARH, UTTAR PRADESH.

And Whereas now the following are the Amended clauses of the Trust:

- a). The Registered Trust/~~Trust~~ of the School shall be renewed from time to time .
- b) A District level officer of the State Government shall be nominated by the Institution as member in the management committee of the school.
- c) At last 10 percent seats in the school be reserved for meritorious children belonging to SC/ST and they shall not pay more than the prescribed fee for different classes in the school run by Uttar Pradesh Board of Secondary Education/Basic Education Council.





- d) No grant shall be sought/demanded from the State Government by the Institution and if the school is earlier recognised by the Board of Secondary Education and the School is affiliated to the Central Board Secondary Education New Delhi/ Council for the Indian School Certificate Examination New Delhi, Recognition from the Council and Grant from the State Government will/shall automatically cease from the date of receipt of affiliation with the said examination councils.
- e) The employees of State aided educational institutions of the teaching and non-teaching employees of the institution will/ shall not be given pay scales and other allowances less than the admissible pay scales and other allowances.
- f) The service conditions of the employees will/shall be made and they will/shall be provided with the retirement benefits admissible to the employees in aided non-government Higher Secondary Schools.
- g) The Institutions shall comply with the orders issued by the State Government from time to time.
- h) Hindi is being taught as compulsory subject in the school and Hindi will/shall be taught compulsory in the future also.
- i) Record of the school shall be kept in the form/ registers.
- j) No change/ will/ shall be made in the above sequences A-1, without the permission of the government and the department.






